## Non-Racing Incident

The stewards received a complaint from Hussain Asghar that Harry Davies had stolen his whip from the jockeys changing room. They interviewed the riders and Allan Smith, the trainer to whom both riders are attached.
The Stewards viewed CCTV footage, which showed Harry Davies surreptitiously removing the whip from where Hussain Asghar changed and placing it in his bag.
Harry Davies admitted having taken the whip and apologized to Hussain Asghar, who he believed had taken his whip when riding out for Mr. Smith, although there was no evidence of this and no distinguishing marks on the whip to identify it as being his.
Mr. Smith confirmed that he knew nothing about the incident and stated that, had he been informed, he would have dealt with it internally.
The Stewards found Harry Davies guilty of improper conduct and imposed a fine of BD 200/- on him, which was below the recommended minimum penalty and took into account his admission of guilt and his apology for his actions.

Being satisfied that no other horse or rider was involved they took no further action. The Stewards were unable to interview the rider as he was receiving medical treatment.
