

# Stewards Report 09/12/2022

Going: Good, Good to Firm in Places

Track: Outer

Rail: From 1400m 3m out tapering to 4m out round the home bend

down to a cutaway at 550m which is 3m out

Stalls: 1000m Middle – 1200m, 1400m & 2000m Inside – 2200m Outside

Non-Runners: R8 – JAMAIS ASSEZ (USA)

#### **Adjourned Cases:**

The Stewards held an Enquiry adjourned from Race 8 on 3 December 2022, into interference shortly after the start involving NIETZSCHE'S STAR (GB) unplaced, ridden by Stephane Ladjadj, NIGEL (GB), which fell later in the race, ridden by Hussain Asghar, PORT DOUGLAS (IRE) placed 3rd, ridden by Salem Alajmi, BENMALEK (IRE) placed 4th, ridden by Charles Perkins and THE COVEX KID (IRE), the winner ridden by Neil Callan.

Having viewed recordings of the race and interviewed the riders, they found Hussain Asghar guilty of careless riding and fined him 50 BD, for moving towards the rail without leaving sufficient room for those runners on his inside. Stephane Ladjadj was found not to have been involved in the interference. Subsequent to the Enquiry, the Stewards received a complaint from Charles Perkins that following this race Neil Callan had ridden alongside him as they were pulling up and behaved and spoke to him in a manner which was outside, what he considered to be acceptable, even bearing in mind what is sometimes said in the heat of the moment after an incident in a race. Having interviewed the riders, the Stewards reminded Neil Callan that he must ensure that he behaves in a professional and appropriate manner at all times when race riding.



#### Race 1 - 01:20 PM (WAHO)

AL JELLABY M833 jumped awkwardly and bumped into AL SUWAITY M887 The stewards cautioned Ali Hussain the rider of AL JELLABY M833 unplaced for using his whip when he could not improve his placing on the run to the line.

# Race 2 - 01:45 PM (LOCAL BRED)

The stewards cautioned Edison Rodriguez the rider of the winner THE GHOST SHIP for using the whip down the shoulder in the forehand position on the run to the line.

# Race 3 - 02:20 PM AL MUHARRAQ CUP (SPONSORED BY SAYACORP)

Alberto Sanna the rider of TAQAREER (IRE) unplaced reported that the gelding had hung badly right-handed in the home straight.

The Stewards held an enquiry into possible interference on the first bend after the start between BOND'S BOY (GB) ridden Liam Keniry and COMMENSEICAL (GB) ridden by Paul Hangan both unplaced. Having viewed recordings of the race the stewards were satisfied that there no riding offence committed. It was noted that as the runners left the cut off rail at around six hundred meters there was interference between MARIE'S DIAMOND (IRE), BOND'S BOY (GB) and CLASSICAL WAVE (GB). Having viewed recordings of the race the stewards were satisfied that there are no riders offence.

# Race 4 - 02:50 PM AL MANAMA CUP (SPONSORED BY BBK)

Permission was given to GET IT to go to the start early.

GET IT (GB) ridden by Patrick Cosgrave was slow away when leaving the stalls. It was noted that when leaving the stalls BAHRAIN PRIDE (GB) ridden by Andrew Breslin unplaced veered right-handed causing OCEAN STAR (IRE) ridden Alberto Sanna placed fourth to be badly hampered. Having viewed recordings of the race the stewards were satisfied that no riding offence had been committed.

The stewards cautioned Neil Callan the rider of the winner NOMADIC EMPIRE (IRE) for using his whip with no time to respond on the run to the line.



### Race 5 - 03:15 PM RASHID EQUESTRIAN AND HORSERACING CLUB CUP

Permission was given to LIVING ART to be mounted from the pre paradering.

### Race 6 - 03:40 PM RASHID EQUESTRIAN AND HORSERACING CLUB CUP

It was noted that Alberto Sanna the rider of QAMARI unplaced was short of room at the two-hundred-meter marker, shortly after which he stopped riding some fourteen strides from the line and was beaten for fourth place by a head. Having viewed recordings of the race and heard his evidence they found Alberta Sanna guilty off failing to ride out to achieve the best possible placing and fined him BD 100/-, the Stewards ordered QAMARI to be routine tested during which the regulatory veterinary officer reported that the gelding showed no clinical abnormalities.

### Race 7 - 04:05 PM IRISH THOROUGHBRED MARKETING CUP

Permission was given to HWAL to be mounted from the pre parade ring. It was noted that interference took place between AL TAI (GB) ridden by Marcialis Jaures placed 2<sup>nd</sup> and RISING MOON (IRE) ridden by Jerome Moutard unplaced around the final bend. After viewing the recording of the incident, the stewards found that no riding offence was involved.

# Race 8 - 04:30 PM IRISH THOROUGHBRED MARKETING CUP
