Race 1 - 01:00 PM **(WAHO)**

Nothing to report.

Race 2 - 01:25 PM **(LOCAL BRED)**

Permission was given to ASALAH to be mounted from the pre parade ring. Charles Perkins the rider of JABRAH, unplaced was cautioned for using the whip without giving his mount time to respond in the home straight. Abdulla Faisal the rider of SEHOO, unplaced used his whip in the wrong place in the home straight. The rider was fined BD 50 this being his second offence of this nature in the current season.

Hussain Asghar reported that BATTLE OF TALAS was slowly away.



Race 3 - 01:50 PM
(LOCAL BRED)

Permission was given to GHAARAH to be mounted from the pre parade ring. The stewards held an inquiry into possible interference from inside the 200-metre marker between the winner RASEEN ridden by Abdulla Faisal, LAVENDAR placed second ridden by Neil Callan and WAQIAAH placed third ridden by Jeffery Syster. After having heard evidence of the riders involved and viewed the recordings of the incident. The stewards found Abdulla Faisal guilty of careless riding and suspended him for one meeting dated 9th of December 2022 as he had allowed his mount to drift left-handed for a considerable distance without taking reasonable measures to avoid interference, carrying LAVENDAR off its intended line, which in turn caused WAQIAAH to take a significant check when against the rail.

The starter reported that SAKHR, trained by Haider Ebrahim had refused to enter the starting stalls and was withdrawn. The trainer was informed that SAKHR could not be entered for a race until having passed a stalls test.

GULF PETROCHEMICAL INDUSTRIES CUP

The stewards held an inquiry into the running and riding of TOPAZ, trained by Haider Ebrahim and ridden by Abdulla Faisal, which, having been slowly away, was allowed to become detached from the main body of the field, and was briefly asked for an effort in the home straight before being eased inside the 400-meter mark. The rider stated that his mount jumped late, having leant back in the stalls and he didn't want to expend too much energy to recover his position early in the race. He added that when he did ask TOPAZ for an effort the gelding felt flat and so he eased him down. The stewards ordered TOPAZ to be routine tested. The Regulatory Veterinary Officer reported that the gelding had no clinical abnormalities when examined. The Stewards noted the rider's explanation.

The starter reported that DIRAB, trained by Talib Ali, had refused to enter the starting stalls, and was withdrawn. The trainer was informed that DIRAB could not be entered for a race until having passed a stalls test.
