### Race 1 - 29/01/2026 05:30 pm

#### GULF AIR CUP

KRUSHAN 1926 was given permission to go to the start early.

KRUSHAN 1926, trained by Adel Abdulla, was led to the start unmounted. The Trainer was reminded that, under Article 12.4, all horses must be ridden to the start.

AL RABDA 1920, unplaced, ridden by Hamed Abdulnabi, hung right-handed in the home straight.



**Race 2 - 29/01/2026 06:00 pm  
LEXUS CUP**

BINT AL JAZEERA and TAREEKH were given permission to be mounted before the parade ring. AAJAY was given permission to be mounted from the pre-parade ring. BUDVA, CALL ME MAYBE, AAJAY, AL YATEEM and PEGASUS were given permission to wear hoods to the start.

TAREEKH, ridden by Ahmed Maki and trained by Ahmed Al Sadah, was unruly in the stalls and was withdrawn at 18:01. The trainer was informed that TAREEKH could not be entered for a race until the gelding had passed a stalls test. The Trainer was also informed that TAREEKH cannot take another stalls test until the Starting Team is satisfied that the gelding is ready to do so.

SCORPIUS, unplaced, ridden by Hasan Al Saffar, ran too free in the early stages of the race. DECEMBER, placed 3rd, ridden by Ali Abdulmajeed, was denied a clear run in the home straight.

ERADA, ridden by Qasim Jameel, pulled up lame in the home straight.

Hussain Asghar, the rider of BINT AL JAZEERA, unplaced, reported that the mare got tired in the home straight, this being her first run of the season.

AAJAY, unplaced, ridden by Edward Greatrex, hung right-handed in the home straight.

Stephane Ladjadj, the rider of BUDVA, unplaced, reported that the gelding was short of room approaching the 200m marker and was subsequently eased thereafter.

The Stewards enquired into possible interference approaching the 200m between CALL ME MAYBE, placed 4th, ridden by Connor Beasley, and AAJAY, unplaced, ridden by Edward Greatrex. Having reviewed the recordings and interviewed the riders, the Stewards cautioned Connor Beasley for careless riding for manoeuvring CALL ME MAYBE left-handed when not sufficiently clear, causing AAJAY to be snatched up.

**Race 3 - 29/01/2026 06:30 pm  
INVESTCORP CUP**

SIGNALMAN (IRE), BLEAK, REFRESHMENT (IRE) and NEPAL (IRE) were given permission to wear hoods to the start.

Ray Dawson, the rider of REFRESHMENT (IRE), placed 2nd, Neil Callan, the rider of KNIGHT OF HONOUR (IRE), placed 3rd, and Rosie Jessop, the rider of the winner NEPAL (IRE), were all cautioned for using the whip with excessive frequency in the home straight.

Jason Hart, the rider of TARTAN CHIEF (GB), unplaced, reported that the gelding had no more to give in the home straight.

**Race 4 - 29/01/2026 07:00 pm  
GRAND SEIKO – BAHRAIN JEWELLERY CENTRE CUP**

PISCES was given permission to be mounted from the pre-parade ring. JADWA, GANADEEL, PISCES, EL BASMA and SAN DIEGO were given permission to wear hoods to the start.

The Stewards enquired into possible interference approaching the 400m between MEAAD, placed 4th, ridden by Neil Callan, and RASHASH, ridden by Marcialis Jaures, who was unseated. Having reviewed the recordings and interviewed the riders, the Stewards found Neil Callan guilty of careless riding and suspended him for 2 meetings (6 and 12 February 2026)



for allowing MEAAD to shift right-handed without taking timely corrective action, causing RASHASH to clip heels and unseat his rider.

**Race 5 - 29/01/2026 07:30 pm  
IRISH THOROUGHBRED MARKETING CUP**

The Stewards, acting on a report from the Regulatory Veterinary Officer, noted that ANWAAR (IRE), trained by Ali Abdulmajeed, had not received a booster vaccination as required under Annexe 9 – Vaccination Protocols. The Trainer was found in breach of Article 21.6 and fined BD 100/. He was informed that ANWAAR (IRE) cannot run until the horse has completed a new primary vaccination course.

ALMONAADY (FR) was given permission to be mounted before the parade ring. EIGHTH AVENUE (IRE) was given permission to be mounted from the pre-parade ring and have a staff member assist with loading into the stalls. ATLANTIC SKY (GB), CRYPTO PRINCESS (IRE), AVIANO (GB), JARHAM (GB), and LADY LYNX (IRE) were given permission to wear hoods to the start.

Permission was given to GIMME SHELTER (USA) and COSMO GOODSPEED (IRE), both trained by Jaber Ramadhan, to wear tongue straps after the declaration stage. The trainer was fined BD 50/- for failing to declare a tongue strap by the deadline.

CARNEGIE HALL (IRE), ridden by Ray Dawson and trained by Jaber Ramadhan, reared in the stalls, unseated his rider, getting his front legs over the infrastructure and was withdrawn at 19:33. The trainer was informed that CARNEGIE HALL (IRE) could not be entered for a race until the gelding had passed a stalls test.

LADY LYNX (IRE), unplaced, ridden by Edward Greatrex, was denied a clear run approaching the 200m marker.

Neil Callan, the rider of ANWAAR (IRE), placed 2nd, was fined BD 50/- for using the whip with excessive frequency from the 400m marker. This was his second such offence at this meeting.

**Race 6 - 29/01/2026 08:00 pm  
BAHRAIN OAKS (SPONSORED BY AL MUZDAHER STUD)**

EVERGREEN, WANISA, PERAST, and INTELLIGENCE were given permission to wear hoods to the start.

ILLUMINATE, unplaced, ridden by Luciano Emanuel Cabrera, ran too free in the early stages of the race.

**Race 7 - 29/01/2026 08:40 pm  
THE ANCHORMAN CUP SPONSORED BY HOWDEN**

SOLDIER'S EMPIRE (IRE) was given permission to be mounted before the parade ring. WAVE RIDER (GB), DAIN MA NUT IN (IRE), SALAMANCA LAD (IRE), VESTIGIA (IRE), WESTRIDGE (FR) and PHOENIX PASSION (IRE) were given permission to wear hoods to the start.

Lewis Edmunds, the rider of the winner DAIN MA NUT IN (IRE), dropped his whip approaching the 200m marker.

## THE HAWAR CUP SPONSORED BY CEBARCO

REDEMPTION TIME (GB) and BURDETT (IRE) were given permission to be mounted from the pre-parade ring. DUBAI BLING (IRE), DREAM OUT LOUD (IRE), DAIRERIN (GB), BLUE DAY (GB), ROMAN DRAGON (GB), BURDETT (IRE), CHIEF MANKATO (GB) and UP THE PACE (IRE) were given permission to wear hoods to the start.

Ali Jan, trainer of DAIRERIN (GB), and Jaber Ramadhan, trainer of DREAM OUT LOUD (IRE), were both cautioned for failing to request permission for a hood to be worn to the start.

PARTISAN HERO (IRE), unplaced, ridden by Luke McAteer, kicked the back of the stalls after being loaded and was removed. The gelding was trotted up by the Veterinary Officer and deemed fit to race.

The Regulatory Veterinary Officer reported that DESERT COP (GB), ridden by Lee Newman, lost his right-fore shoe during the race.

The Stewards noted that approaching the 400m, COMMANCHE FALLS (GB), placed 2nd, ridden by Connor Beasley, shifted slightly left-handed as SPANGLED MAC (IRE) moved marginally right-handed, causing KAASIB (IRE), unplaced, ridden by Neil Callan, to be short of room. Having reviewed the recordings, the Stewards were satisfied that no riding offence had been committed and took no further action.

Stephane Ladjadj, the rider of NATIONWIDE (IRE), unplaced, was cautioned for failing to weigh-out in the correct coloured cap.

### Race 9 - 29/01/2026 09:50 pm

#### Race 9

RIYAHEEN and AUTHORITY were given permission to be mounted from the pre-parade ring. RIYAHEEN, AUTHORITY, and RAHEEL were given permission to wear hoods to the start. UPTOYOUORDOWNTOME, unplaced, ridden by Alejandro Brun, hung right-handed in the home straight.

The Stewards enquired into why Abdulla Al Hawaj, the rider of RIYAHEEN, placed 7th, appeared to stop riding in the final strides and was beaten a neck for 6th place. Having interviewed the rider and viewed the recordings, the Stewards cautioned him for failing to ride his horse to achieve the best possible placing.
