**Adjourned Cases:** The Stewards received a report from the Regulatory

Veterinary Officer (RVO) that, following an inspection, he found that ASEELA, declared to run in Race 8 (7:30 pm), trained by Abdulla Kuwaiti, had reduced sensation in her right fore distal limb, and swelling over the inside





sesamoid bone, and therefore deemed her not fit to race. The Stewards withdrew ASEELA at 6:55 pm. They held an enquiry and, after hearing evidence from the trainer and RVO, adjourned the enquiry to a later date. They further informed the trainer that ASEELA could not be entered to race until samples taken from ASEELA had been analysed.

### Race 1 - 04:00 pm BAHRAIN BOURSE ARABIAN CUP

KRUSHAN M1080, placed 3rd, ridden by Hussain Asghar, was slowly away from the stalls.

OBEYAN 1923, placed 4th, ridden by Ebrahim Nader, ran too free during the early stages of the race.

#### Race 2 - 04:30 pm BHB OPENING BELL CUP

SHARID, JBARAH, and SAKHR were given permission to wear hoods and have them removed at the stalls. AL QAMAIRAH was given permission to be mounted from the pre-parade ring.

Hasan Ali, rider of EZZ ALBAHRAIN, was unseated as the horse left the stalls. Having reviewed the recordings, the Stewards found that Hasan Ali was unseated due to the horse bumping the side of the stalls as he jumped out.

The Stewards enquired into possible interference turning into the home straight between CALL OF DUTY, placed 4th, ridden by Lee Newman, and THE GHOST SHIP, unplaced, ridden by Gavin Ryan. Having reviewed the recordings and interviewed the riders, the Stewards found that CALL OF DUTY was slightly short of room turning for home, due in part to a loose horse shifting direction, resulting in him clipping the heels of THE GHOST SHIP, which was in front of him and slowing at the time. The Stewards were satisfied that the interference was accidental and took no further action.





#### Race 3 - 05:00 pm CAPITAL MARKETS CUP

CATHERINE PARR and EIGHTH AVENUE were given permission to wear hoods and have them removed at the stalls.

HARDTAIL (ARG), placed 2nd, ridden by Ebrahim Nader, ran too free during the early stages of the race.

MUJTAHID (IRE), ridden by Hussain Asghar, was pulled up entering the home straight and was dismounted. The Stewards reviewed the recordings and interviewed the rider and found that the saddle had slipped forward.

The Veterinary Officer reported that HOTTEST WOOD (GB), unplaced, ridden by Franky Vonhonsebrouck, bled from the nose.

Ahmed Maki, rider of LECALE'S DESTINY (IRE), unplaced, was cautioned for using the whip when out of contention in the home straight.

# Race 4 - 05:30 pm BAHRAIN BOURSE SPRINT CUP

DEHAM, RETAJ, and RAHEEL were given permission to wear hoods and have them removed at the stalls. DEHAM was given permission to go to the start early.

The Veterinary Officer reported that QUEENS MEMENTO, unplaced, ridden by Alejandro Brun, bled from the nose.

The Stewards enquired into possible interference inside the final 400m between RETAJ, placed 2nd, ridden by Hasan Al Saffar, RAHEEL, unplaced, ridden by Mirko Sanna, and HAMIYA, placed 3rd, ridden by Hussain Asghar. Having reviewed the recordings and interviewed the riders, the Stewards found Hasan Al Saffar guilty of careless riding and fined him BD 50/- for allowing his mount to drift left-handed away from the whip without correction, taking RAHEEL and HAMIYA off their intended line and then causing RAHEEL to have to be eased off heels.





#### Race 5 - 06:00 pm BAHRAIN BOURSE CUP

KING OF THE THRONE (USA) and EL INTROVERTIDO (ARG) were given permission to wear hoods and have them removed at the stalls.

Marcialis Jaures, the rider of the winner MALAKYE (IRE), was fined BD 50/- for using the whip with excessive frequency in the home straight, this being the rider's second offence this season.

# Race 6 - 06:30 pm BAHRAIN BOURSE MILE CUP

ATLANTIC SKY (GB) and BE LUCKY MY SON (IRE) were given permission to wear hoods and have them removed at the stalls.

ASIMOV (GB), ridden by Mirko Sanna, was observed with blood in his mouth in the parade ring. The gelding was checked by the vet at the start and deemed fit to race.

BE LUCKY MY SON (IRE), unplaced, ridden by Mark Lawson, and ANWAAR (IRE), unplaced, ridden by Hasan Al Saffar, ran too free during the early stages of the race.

The Stewards enquired into possible interference approaching the final 200m between BE LUCKY MY SON (IRE), unplaced, ridden by Mark Lawson, and PURGATORY (GB), placed 3rd, ridden by Adnan Jaffar. Having reviewed the recordings and interviewed the riders, the Stewards cautioned Mark Lawson for careless riding for allowing BE LUCKY MY SON (IRE) to shift right-handed away from the whip, taking PURGATORY (GB) off his intended line.

# Race 7 - 07:00 pm BAHRAIN BOURSE EXCELLENCE CUP

AQUILA was given permission to be mounted before the parade ring. EL BASMA, MISTER DOLLAR, MISHWAAR and NAWADI were given permission to wear hoods and have them removed at the stalls.

The Starters reported that MIND YOUR LANGUAGE, unplaced, ridden by Hasan Asghar, reared in the stalls and made contact with the front gate. The colt was inspected by the vet and deemed fit to race.





Ali Moosa, the rider of BUDVA, unplaced, reported that the gelding ran green and hung right-handed throughout. Following an inspection after the race, the Veterinary Officer reported no abnormalities with the gelding.

Qasim Jameel, the rider of MONACO, unplaced, was cautioned for using the whip when out of contention in the home straight.

# Race 8 - 07:30 pm BAHRAIN BOURSE APPRENTICE CUP

KHAWAFY was given permission to be mounted before the parade ring. THARB and WEWONITSIXTIMES were given permission to wear hoods and have them removed at the stalls.

ASEELA, trained by Abdulla Kuwaiti, was withdrawn on veterinary advice at 6:55 pm (see adjourned cases).

The Stewards enquired into possible interference approaching the 400m between LAHAAYAB, unplaced, ridden by Husain Abdulla, and LATIF, unplaced, ridden by Mohammed Hassan. Having reviewed the recordings and interviewed the riders, the Stewards found Husain Abdulla guilty of careless riding and fined him BD 50/- for shifting LAHAAYAB right-handed when not sufficiently clear, bumping LATIF and forcing him onto the rail.

The Veterinary Officer reported that LATIF, unplaced, ridden by Mohammed Hassan, bled from the nose.

#### Race 9 - 08:00 pm BHB CLOSING BELL CUP

ZOMAAN was given permission to be mounted before the parade ring. POSH PLACE, ZOMAAN, TOPAZ and AAJAY were given permission to wear hoods and have them removed at the stalls.

TOPAZ, trained by Ali Nasser, refused to enter the stalls and was withdrawn by the Starter at 8:02 pm. The trainer was informed that TOPAZ could not be entered for a race until the gelding had passed a stalls test.
