Race 1 - 05:30 pm ARABIAN HORSE EQUESTRIAN SERVICES CUP (WAHO) SPONSORED BY CARR & DAY & MARTIN

KRUSHAN 1926 was given permission to go to the start early.

Race 2 - 06:00 pm

Hasan Asghar, the rider of LAZARUS DREAM (IRE), was cautioned for failing to leave the parade ring when instructed to do so by the paddock steward.

ALMONAADY (FR), placed 3rd, ridden by Abdulla Al Hawaj, was unruly going to the start and was led. The gelding also ran too free during the early stages of the race.

FORBIDDEN LAND (IRE), placed 4th, ridden by Ali Moosa, hung right-handed in the home straight.

The Veterinary Officer reported that ROOSEVELT'S GRIT (GB), unplaced, ridden by Hussain Mohamed, bled from the nose.

The Stewards enquired into possible interference shortly after the winning line between the winner SHIELD WALL (IRE), ridden by Ahmed Hussain, LAZARUS DREAM (IRE), placed 2nd, ridden by Hasan Asghar, and ALMONAADY (FR), placed 3rd, ridden by Abdulla Al Hawaj. Having reviewed the recordings and interviewed the riders, the Stewards found Ahmed Hussain guilty of careless riding and fined him BD 50/- for taking his hand off the reins and allowing SHIELD WALL (IRE) to shift sharply right-handed when not sufficiently clear, causing ALMONAADY (FR) to be short of room and forcing LAZARUS DREAM (IRE) to make contact with the rail. The Stewards further cautioned Ahmed Hussain for removing his hand from the reins and celebrating before the winning line.

Race 3 - 06:30 pm ARABIAN HORSE EQUESTRIAN SERVICES MILE CUP SPONSORED BY FORAN

CALIFORNIA was given permission to wear a hood and have it removed at the stalls.

RIDER ON THE STORM, placed 3rd, ridden by Marcialis Jaures, and NIGHT LANTERN, placed 4th, ridden by Lee Newman, both ran too free during the early stages of the race.





Race 4 - 07:00 pm

INDISPENSABLE (GB), EDWARD CORNELIUS (IRE), and NINE BELOW ZERO (GB) were given permission to wear hoods and have them removed at the stalls. ROSA MYSTICA (IRE) was given permission to be mounted from the pre-parade ring.

ROSA MYSTICA (IRE), ridden by Adnan Jaffar and trained by Jaffar Radhi refused to load and was withdrawn at 7:02 pm. The trainer was informed that ROSA MYSTICA (IRE) could not be entered for a race until the mare had passed a stalls test.

An enquiry was held to consider the placings in this race after possible interference approaching the 400m marker between SHARKII (IRE), placed 2nd, ridden by Mark Lawson, and NEPTUNIAN (IRE), placed 3rd, ridden by A.Rahim Jasim. Having reviewed the recordings and interviewed the riders, the Stewards found Mark Lawson guilty of careless riding and fined him BD 50/- for allowing SHARKII (IRE) to drift away from the whip, causing NEPTUNIAN (IRE) to be short of room and have to be eased off heels. The Stewards considered that the interference had not improved SHARKII (IRE) 's placing, as NEPTUNIAN (IRE) had time to pass SHARKII (IRE) following the interference and was losing ground on the approach to the line to be beaten three-quarters of a length.

Race 5 - 07:30 pm ARABIAN HORSE EQUESTRIAN SERVICES SPRINT CUP SPONSORED BY RED MILLS

RAMAZAN (IRE) and AVA GO JOE (IRE) were given permission to wear hoods and have them removed at the stalls.

PIZ NAIR (IRE), placed 3rd, ridden by Ebrahim Nader, ran too free during the early stages of the race.





Race 6 - 08:00 pm

BUDVA and RAHEEL were given permission to wear hoods and have them removed at the stalls.

MEAAD, unplaced, ridden by Anas Al Siyabi, was slowly away from the stalls.

The Stewards enquired into the running and riding of BUDVA, ridden by Stephane Ladjadj and trained by Fawzi Nass, which broke well and was in touch until being heavily eased approaching the 400m marker, finishing 8th of 14 beaten over 26.5 lengths. They reviewed the recordings and interviewed the rider and trainer's representative. The rider stated that he spoke to the trainer on the telephone before the race, and as he had ridden BUDVA at home and they were unsure of the gelding's optimum trip, he was told to break and ride a race. He added that BUDVA broke well and was able to get cover, but approaching 400m, the gelding began to hang right-handed and he therefore eased him approaching the 200m marker, as he felt something was amiss and that BUDVA may be suffering from sore shins. He further added that BUDVA was disappointing and in his opinion was of limited ability. The trainer's representative confirmed the rider's evidence. The Veterinary Officer reported that he could find no abnormalities following two post-race examinations of the horse during routine testing. The Stewards noted the rider's and trainer's explanations.

Race 7 - 08:30 pm

MISS YVONNE (IRE) and BE LUCKY MY SON (IRE) were given permission to wear hoods and have them removed at the stalls.

TAQAREER (IRE), unplaced, ridden by Hasan Al Saffar, ran too free during the early stages of the race and hung right-handed in the home straight.

BE LUCKY MY SON (IRE), unplaced, ridden by Mark Lawson, hung right-handed in the home straight.





Race 8 - 09:00 pm REHC CUP

PANNING FOR GOLD (IRE) was given permission to wear a hood and have it removed at the stalls.

Ebrahim Nader, the rider of the winner, CRACKSKING (GB), was cautioned for taking his hand off the reins and celebrating before the winning line.

Race 9 - 09:30 pm

TAJ MAHAL was given permission to wear a hood and have it removed at the stalls.

SCORPIOUS, placed 4th, ridden by Husain Makki, ran free during the early stages of the race and hung right-handed in the home straight.

TAJ MAHAL, unplaced, ridden by Hussain Asghar, hung right-handed in the closing stages of the race.
