TOPAZ, trained by Ali Nasser, and TAREEKH, trained by Ahmed Alsadah, failed their stalls tests. The Trainers were informed that TOPAZ and TAREEKH cannot be entered to race until the geldings had passed a stalls test. The Trainers were also informed that TOPAZ and TAREEKH cannot take another stalls test until the Starting Team are satisfied that the geldings are ready to do so.

Race 2 - 04:30 pm

MAXIMUM IMPACT (GB) was given permission to wear a hood and have it removed at the stalls.

SALVUCCIO (GB), unplaced, ridden by Benoit De La Sayette, was slowly away from the stalls.

Race 3 - 05:00 pm

REHC SPRINT CUP

AL NUWAYEF was given permission to wear a hood, have it removed at the stalls, and to go to the start early.

Ebrahim Nader, the rider of the winner, ZEAL, was fined BD 50/- for taking his hand off the reins and celebrating before the winning line, this being his second offence of this nature this season.

Race 4 - 05:30 pm

MEARALL (IRE) and LABALABA (FR) were given permission to wear hoods and have them removed at the stalls. LABALABA (FR) was given permission to go to the start early.

Jason Hart, the rider of KAASIB (IRE), unplaced, reported that the gelding reared as the stalls opened and was slowly away.

The Regulatory Veterinary Officer (RVO) reported that NATIONWIDE (IRE), trained by Fawzi Nass, recorded a pre-race TCO2 reading above the accepted level and was withdrawn at 5.00 pm. After hearing evidence from the RVO and the Trainer, the Stewards adjourned the enquiry to a later date.



Race 5 - 06:00 pm
REDX INDUSTRIES BAHRAIN CUP

BYLINE (GB), RAWYAAN (GB) and PURE DREAMER (GB) were given permission to wear hoods and have them removed at the stalls.

Race 6 - 06:30 pm

MR IRRELEVANT (IRE), THE PARENT (GB) and GIMMIE SHELTER (USA) were given permission to wear hoods and have them removed at the stalls. WINFORGLORY (IRE) was given permission to be mounted from the pre-parade ring.

Race 7 - 07:00 pm
REDX INDUSTRIES MAIDENS CUP

POSH PLACE, PARIS, PERAST, TALQA and TOMAHAWK were given permission to wear hoods and have them removed at the stalls.

Ali Nasser, trainer of TALQA, was cautioned for failing to request permission for a hood to be worn in the parade ring and removed at the stalls.

GOLDEN ARROW, unplaced, ridden by Adnan Jaffar, ran too free during the early stages of the race.

The Stewards noted that VISIONARY, placed 4th, ridden by Mark Lawson, shifted quickly right-handed approaching the 400m marker, causing interference to GOLDEN ARROW, unplaced, ridden by Adnan Jaffar. They were satisfied that no riding offence was committed and took no further action.

The Stewards enquired into the running and riding of TOMAHAWK, ridden by Stephane Ladjadj and trained by Fawzi Nass, which broke well and then became detached from the field before running on well from the 400m marker to finish 11th of 15, beaten 7.5 lengths. They reviewed the recordings and interviewed the rider and the trainer's representative. The rider stated that his instructions from the trainer were to jump out, take a position, and ride a race. He added that the colt was outpaced early on, and he did not feel he was moving well when entering the straight, but on switching leads inside the 200m, he ran on well. In his opinion, the horse would benefit from a longer distance. The trainer's representative confirmed the rider's evidence and instructions. The Regulatory Veterinary Officer reported that he could find no abnormalities following a post-



race examination of the horse during routine testing. The Stewards noted the rider's and trainer's representative explanations.

Race 8 - 07:30 pm

REDX INDUSTRIES BAHRAIN BRED CUP

ZOMAAN and PEGASUS were given permission to wear hoods and have them removed at the stalls. ZOMAAN was given permission to be mounted from the pre-parade ring.

Lee Newman, the rider of SPACE X, placed 4th, was fined BD 50/- for using the whip with excessive frequency in the home straight.
