TOPAZ, trained by Ali Nasser, failed his stalls test. The Trainer was informed that TOPAZ cannot be entered for a race until the gelding has passed a stalls test. The Trainer was also informed that TOPAZ cannot take another stalls test until 26/12/2025, and only if the Starting Team is satisfied

that the gelding is ready to do so.

#### Race 1 - 12/12/2025 04:00 pm

OBEYAN 1893 was given permission to wear a hood to the start.

KRUSHAN M1092, ridden by Hasan Al Saffar and trained by Abbas Al Mawali, was unruly in the stalls and withdrawn by the Starter at 4:02 pm. The trainer was informed that KRUSHAN M1092 (IRE) could not be entered for a race until the horse had passed a stalls test.

#### Race 2 - 12/12/2025 04:30 pm

GANADEEL, CALL TO COURT, NAWADI, CALL ME MAYBE, SOUTH CHINA SEA and MAZAAYA were given permission to wear hoods to the start.

CALL TO COURT, unplaced and ridden by Qasim Jameel, ran too free in the early stages of the race.

#### Race 3 - 12/12/2025 05:00 pm

AUTHORITY and NAJRAN were given permission to wear hoods to the start. AUTHORITY was given permission to be mounted from the pre-parade ring.

Rosie Jessop, the rider of MAGSOODA, unplaced, reported that the mare was slowly away from the stalls.

The Stewards enquired into possible interference from approaching the 200m marker involving PRINCESS OF MONACO, placed 2nd, ridden by Hasan Asghar, NAAHY, placed 3rd, ridden by Qasim Jameel, AUTHORITY, unplaced, ridden by Ebrahim Nadar, ANWAAR, placed 4th, ridden by Marcialis Jaures, and WARDA, unplaced, ridden by Husain Makki. Having reviewed the recordings and interviewed the riders, the Stewards found there were two instances of interference. In the first incident, they found Hasan Asghar guilty of careless riding and cautioned him for allowing PRINCESS OF MONACO to shift right-handed onto NAAHY without correction, causing him to be taken off his intended line. In the second incident, the Stewards found Ebrahim Nader guilty of careless riding and fined him BD 50/- for allowing AUTHORITY to shift right-handed, causing interference to ANWAAR, which in turn interfered with WARDA, who had to be snatched up against the rail.

#### Race 4 - 12/12/2025 05:30 pm

CAPRICORNUS and KHAWAFY were given permission to be mounted before the parade ring. WEWONITSIXTIMES, SAKHR and JBARAH were given permission to wear hoods to the start.

#### Race 6 - 12/12/2025 06:30 pm

PORTOFINO, AAJAY and PISCES were given permission to wear hoods to the start. PISCES was given permission to be mounted from the pre-parade ring.

The Stewards noted that inside the final 200m, AAJAY, unplaced, ridden by Mark Lawson, shifted right-handed, making contact with PORTOFINO, placed 4th, ridden by Benoit De La Sayette. They were satisfied that no riding offence was committed and took no further action.

## Race 7 - 12/12/2025 07:00 pm NAD HOLDING CUP

AL SHABABI (GB) was given permission to wear a hood to the start.

The Stewards noted that approaching 400m, the winner HOT DANCER (GB), ridden by Jason Hart, shifted left-handed at the same time as AL SHABABI (GB), placed 2nd, ridden by Ebrahim Nader, shifted right-handed, making contact for a stride. They were satisfied that no riding offence was committed and took no further action.

#### Race 8 - 12/12/2025 07:30 pm AL RAFFAH MEDIA CUP

DREAM OUT LOUD (IRE), HAWAIIAN (GB), COVER POINT (GB) and MEARALL (IRE) were given permission to wear hoods to the start. ROSA MYSTICA (IRE) was given permission to go to the start early and have a staff member assist with loading her into the stalls.

SAHARA SPEAR (GB), unplaced, ridden by Ahmed Hussain, was slowly away from the stalls.

Mirko Sanna, the rider of HAWAIIAN (GB), unplaced, reported that the gelding had a breathing problem.

COVER POINT (GB), unplaced, ridden by Ebrahim Nader, lost his right-fore shoe during the race.
